The United States Marines have their own Law within and under The UCMJ, called Marine Law of 1834. Each Branch has Regulations and Symbolizations.

Donald Trump was approached by Military and World Generals to be the Leader aka the Frontman to and for the people of this brilliant, Biblical, Monumental, and Historical COVERT OPERATION in where the planning began in **2012**.

From 2017 to 2021, a lot of you thought that certain Trump Team Members, Staff, Administration, and Military 'turned' on him, but they didn't, it was a part of the Operation, they're called "White Hat Operatives." Optics within optics.

Also, states do not “call” their Election as did Arizona with 2% reporting “in.” As well as a few others that called theirs for “Biden” with percentages well under 50%.

Also notice when you click and read... December 16, 1941. NINE days after Pearl Harbor.

The Military and President Trump **already** knew there was Election Fraud, hence the Executive Order 13848, 13959, Presidential Emergencies, and the Federalization of the National Guard to Active Duty.

Well, well, well... the NSA. The same thing all Armed Forces Soldiers and Congressmen swear under. NSA's.

What happened in **2018**? President Trump's HISTORIC **Executive Order 13848** with a Presidential Emergency, and Election Fraud Committee to be activated on November 3, 2020, and report all the way into Fall of 2021 with KEY DATES in that 2018 order.

A little time before the Election, a PEAD was written to transfer ALL governing authority to the President of the United States upon a *triggering* event in which a COG would also be accompanying the PEAD.

That triggering event was proof of a foreign government directly or indirectly colluding with election officials to change the results of the election.

The night of the Election, November 3, 2020, counting was intentionally stopped with plenty of hours of time left to finish the count.

Around 4 AM on November 4, 2020, fraudulent votes were delivered to key counting locations in Georgia, Pennsylvania, Michigan, Wisconsin, and Arizona.

Everything he said was optics and code language and it flew right over 99% of everyone including the “legal expert” media and “professional” journalists.

We will be transitioning to a 2nd Trump presidency: Manuel L. Quezon was still President of the Philippines when Manila fell. (Read: Commonwealth Act Number 671 again).

We’re ready: The PEAD was already activated along with Executive Orders, Maritime Law, Presidential Emergencies, and troops were on standby getting ready.

The World is watching: And stilllll watching.

That's how the Military had even more evidence all over the world than ever before due to our technology with the Space Force, National Security Agency, the SCIF, and the National Quantum Initiative and System.

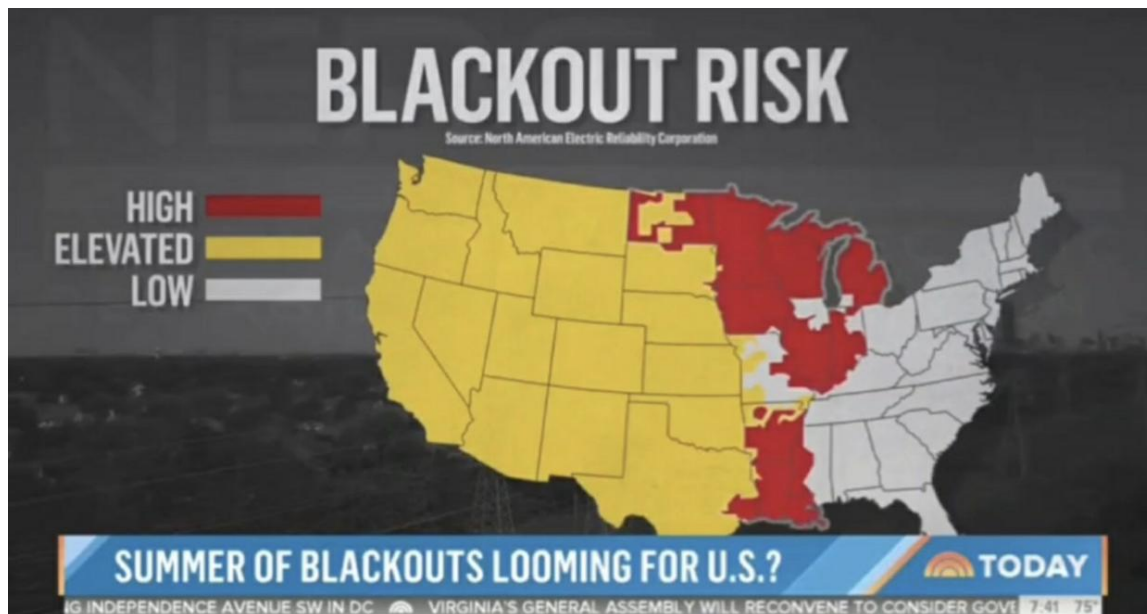
Hence President Trump's Social Media System... 99% of you thought his Truth Social just launched, well, it did.

This is succinctly stated as follows: "All laws which are repugnant to the Constitution are null and void." **Marbury vs. Madison 1803**, 5 U.S. (2 Cranch) 137, 174, 176.

We recognize, and must **prepare for, the possibility of unforeseen events** including natural disasters, pandemics, cyber threats, and kinetic or electromagnetic pulse attacks. **We must be prepared as a Nation, as a Federal Government, and as individual citizens to preserve, protect, and defend our way of life.**

The *Strategy* builds on the *National Continuity Policy* and provides guidance to the Executive Office of the President and Federal executive departments and agencies to increase the executive branch's resilience. Our current and future prosperity depend on our ability to reduce the vulnerability of our critical infrastructure to cyber, physical, and electromagnetic attack. The government and private sector must work together to reduce vulnerabilities and design infrastructure that addresses preparedness and resilience from the start.

The follow-on *Federal Mission Resilience Implementation Plan* will ensure that our Nation's efforts and resources will be brought to bear in a coordinated manner through integrated **Continuity of Operations and Continuity of Government programs** interwoven into routine, day-to-day government operations. Working together, **we will prioritize the security, prosperity, and interests of the American people to confront the challenges of tomorrow.**

"The Act empowers the U.S. President to *call into service* the U.S. Armed Forces and the National Guard"

Public Law 114-328 was amended to include Guam and the US Virgin Islands under Ch. 13 jurisdiction. §252: "Use of militia and armed forces to enforce Federal authority" currently reads:

Whenever the President considers that unlawful obstructions, combinations, or assemblages, or rebellion against the authority of the United States, make it impracticable to enforce the laws of the United States in any State by the ordinary course of judicial proceedings, he may call into Federal service such of the militia of any State, and use such of the armed forces, as he considers necessary to enforce those laws or to suppress the rebellion.

Did you catch the keywords above? The act empowers the President to CALL INTO service the U.S. Armed Forces....

Why would he have to call ***into service*** U.S. Armed Forces soldiers? Notice how that's separated from the National Guard. Which is saying he **activated active** Forces to Federal Duty.

Why would he have to activate active duty if they're active duty?

They leave Garrison and enter in War Zone... huge difference.

Not only did he activate the 1st and 2nd line of defense, he signed Executive Order 13919 in April 2020, which gave the Secretary of Defense full authority to activate the Reserve components.

When's the last time we've Federally activated all 50 states Reserve components?

"The Act empowers the U.S. president to call into service the U.S. Armed Forces and the National Guard"

Public Law 114-328 was amended to include Guam and the US Virgin Islands under Ch. 13 jurisdiction. §252: "Use of militia and armed forces to enforce Federal authority" currently reads

Whenever the President considers that unlawful obstructions, combinations, or assemblages, or rebellion against the authority of the United States, make it impracticable to enforce the laws of the United States in any State by the ordinary course of judicial proceedings, he may call into Federal service such of the militia of any State, and use such of the armed forces, as he considers necessary to enforce those laws or to suppress the rebellion.

The Insurrection Act has been invoked 23 times since its signing in 1807. "Invoked" does not mean it has to be publicly voiced by the President. Invoked means by its actions of its purpose such as "calling into service the US Armed Forces and National Guard."

This happened in my Grandparents lifetime though it was a World War not a War on our Constitution and Foundation:

Franklin D. Roosevelt served THREE Presidential terms due to powers extended by the President (Articles of the Constitution) and Martial Law.

The only song played at the Funeral Service for Josephine Biden was "Honors March One."

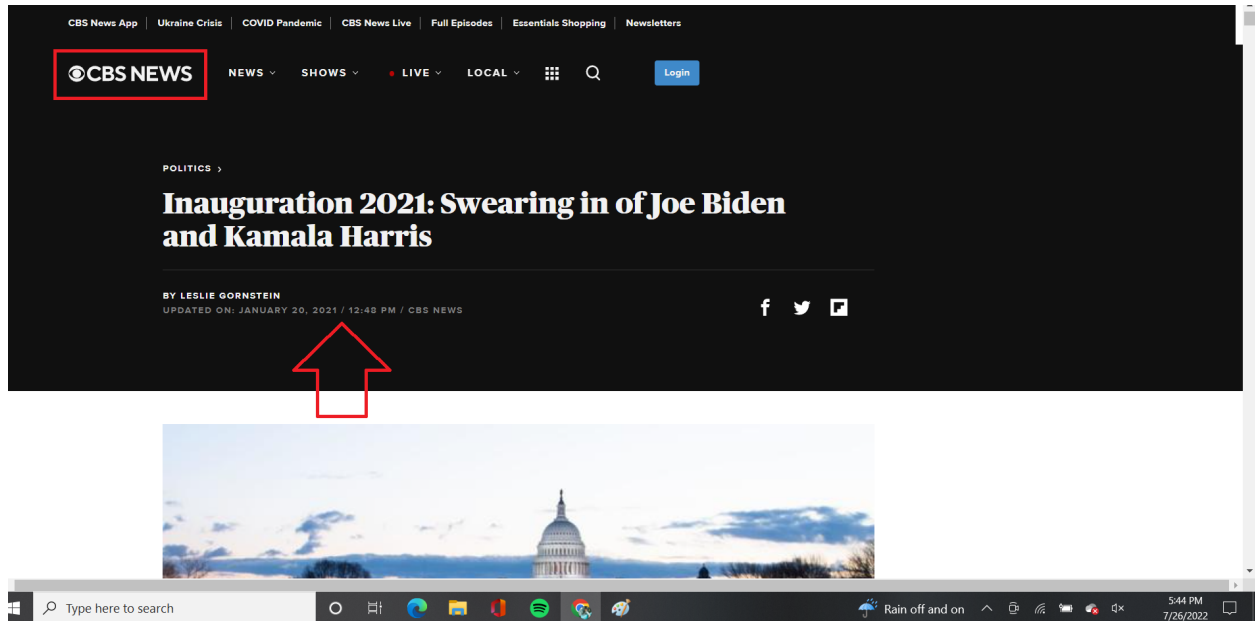

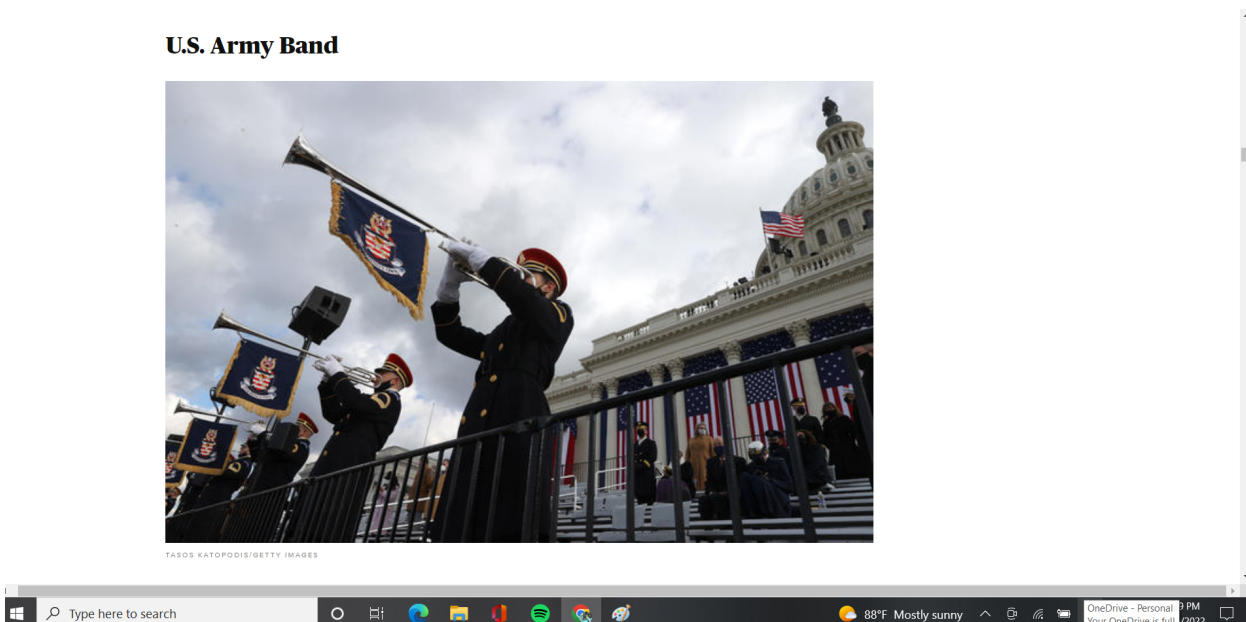

NQIA – The National Quantum Initiative Act

PUBLIC LAW 115-368—DEC. 21, 2018

TITLE I—NATIONAL QUANTUM INITIATIVE

SEC. 101. NATIONAL QUANTUM INITIATIVE PROGRAM.

(a) IN GENERAL.—The President shall implement a National Quantum Initiative Program.

(b) REQUIREMENTS.—In carrying out the Program, the President, acting through Federal agencies, councils, working groups, subcommittees, and the Coordination Office, as the President considers appropriate, shall—

(1) establish the goals, priorities, and metrics for a 10-year plan to accelerate development of quantum information science and technology applications in the United States;

(2) invest in fundamental Federal quantum information

The National Quantum Initiative Act (NQI Act) was signed into law by President Trump on December 21, 2018 “to accelerate quantum research and development for the economic and national security of the United States.” The NQI Act authorizes the National Institute of Standards and Technology (NIST), the National Science Foundation (NSF), and the Department of Energy (DOE), to strengthen QIS Programs, Centers, and Consortia. The NQI Act also calls for a coordinated approach to QIS Research and Development (R&D) efforts across the United States Government, including the civilian, defense, and intelligence sectors. To guide these actions, the NQI Act legislates some responsibilities for the National Science and Technology Council Subcommittee on Quantum Information Science (SCQIS), the National Quantum Coordination Office (NQCO), and the National Quantum Initiative Advisory Committee (NQIAC). Recognizing that QIS technologies have commercial and defense applications, additional authorization for QIS R&D is legislated by the National Defense Authorization Act. Civilian, defense, and intelligence agencies all have a long history of investments in QIS, and have a stake in future QIS discoveries and technology development. The National Quantum Initiative now provides an overarching framework to strengthen and coordinate QIS R&D activities across U.S. Departments and Agencies, private sector industry, and the academic community.

§8. Respect for flag

No disrespect should be shown to the flag of the United States of America; the flag should not be dipped to any person or thing. Regimental colors, State flags, and organization or institutional flags are to be dipped as a mark of honor.

- (a) The flag should never be displayed with the union down, except as a signal of dire distress in instances of extreme danger to life or property.
 - (b) The flag should never touch anything beneath it, such as the ground, the floor, water, or merchandise.
 - (c) The flag should never be carried flat or horizontally, but always aloft and free.
 - (d) The flag should never be used as wearing apparel, bedding, or drapery. It should never be festooned, drawn back, nor up, in folds, but always allowed to fall free. Bunting of blue, white, and red, always arranged with the blue above, the white in the middle, and the red below, should be used for covering a speaker's desk, draping the front of the platform, and for decoration in general.
 - (e) The flag should never be fastened, displayed, used, or stored in such a manner as to permit it to be easily torn, soiled, or damaged in any way.
 - (f) The flag should never be used as a covering for a ceiling.
 - (g) The flag should never have placed upon it, nor on any part of it, nor attached to it any mark, insignia, letter, word, figure, design, picture, or drawing of any nature.
 - (h) The flag should never be used as a receptacle for receiving, holding, carrying, or delivering anything.
 - (i) The flag should never be used for advertising purposes in any manner whatsoever. It should not be embroidered on such articles as cushions or handkerchiefs and the like, printed or otherwise impressed on paper napkins or boxes or anything that is designed for temporary use and discard. Advertising signs should not be fastened to a staff or halyard from which the flag is flown.
 - (j) No part of the flag should ever be used as a costume or athletic uniform. However, a flag patch may be affixed to the uniform of military personnel, firemen, policemen, and members of patriotic organizations. The flag represents a living country and is itself considered a living thing. Therefore, the lapel flag pin being a replica, should be worn on the left lapel near the heart.
 - (k) The flag, when it is in such condition that it is no longer a fitting emblem for display, should be destroyed in a dignified way, preferably by burning.
- (Added Pub. L. 105–225, §2(a), Aug. 12, 1998, 112 Stat. 1497.)

§10. Modification of rules and customs by President

Any rule or custom pertaining to the display of the flag of the United States of America, set forth herein, may be altered, modified, or repealed, or additional rules with respect thereto may be prescribed, by the Commander in Chief of the Armed Forces of the United States, whenever he deems it to be appropriate or desirable; and any such alteration or additional rule shall be set forth in a proclamation.

The suit is often green or [desert tan](#) in color, with multiple pockets for specific pieces of gear (such as a clear plastic pocket on the thigh intended to house a map of the aircraft's planned flight path), but color, style, and cut vary greatly from country to country. The current model flight suit for the US military is the CWU 27/P and is available in [sage green](#) and desert tan. Commercial flight suits for civilian flying are also available, and are frequently used by helicopter crew (including non-pilots such as flight engineers, paramedics, and nurses), aerobatic pilots, and others who desire a practical "uniform".

Although there are multiple pockets on the current CWU 27/P flight suit, all pockets are placed on the front of the flight suit or on the arms or legs. There are no pockets on the back of the flight suit. This design allows easier access to the pockets while the wearer is sitting (such as in the cockpit of an aircraft), and ensures that the wearer in a seated position does not have to sit on any items in a back pocket (such as a wallet).


Members of the [United States Marine Corps](#) wore flight suits during most vehicle patrols and ground combat operations in Iraq and Afghanistan, because their standard camouflage utilities were not flame-resistant. Flight suits have now been phased out among ground personnel with the introduction of the [Flame Resistant Organizational Gear](#), or "FROG" suit, which resembles the standard camouflage utilities.

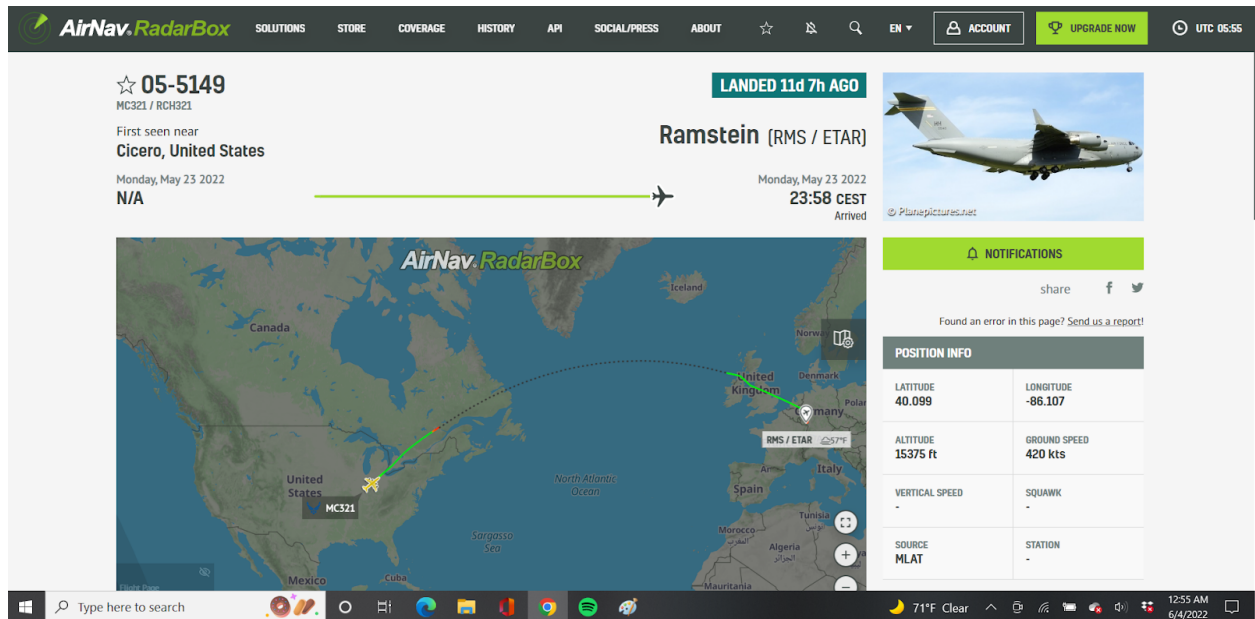

But while Tarabalka was a distinguished war hero, he was not the “Ghost” — because there never was such a person, Ukraine said.
